A.W.S. Ramps

Between 07.30–17.00 (Saturday) all existing A.W.S. ramps redundant to Stage 3 will be recovered at Long Dyke Junction, Newtown West, Cardiff East, Cardiff West, Canton Sidings, Leckwith Junction, Penarth Curve East, Penarth Curve North and Penarth Curve South and new ramps installed in accordance with their provision as shewn in Notice No. W.W.209. From 07.30, the cab signals given at all A.W.S. ramps within the above limits should be ignored until the new signalling is brought into use.

Main Occupation

Phase A. (23.15, Saturday to 12.15, Sunday):-

The occupation will start on cessation of the day's service on the Valley Lines. The punctuality of this service **must** be maintained and in order to afford completion of their journeys by passengers who may miss their connections road transport will be available.

Absolute occupation of the following lines will be granted:-

Up and Down Relief Lines between Long Dyke Junction and Cardiff East. Platforms 4, 6, 7, 8 and 9 at Cardiff General.

All Penarth Lines at Cardiff West.

Method of Signalling

Normal signalling will be maintained at St. Fagans, Leckwith Junction, Canton Sidings (will be open) and Cardiff West, except that Cardiff West Down Inner Home signal No. 4 will be handsignalled.

Normal signalling will be maintained (with removal of some track circuit controls) on the Up Main and Down Main at Cardiff East, Newtown West and Long Dyke Junction, except that Newtown West Down Main Home and Cardiff East Down Main Home will be handsignalled.

All Up trains will use Platform 2, those from Bridgend running up Relief from Leckwith Junction.

Down trains terminating at Cardiff will be handsignalled out of Platform 3 to the Carriage Sidings.

Between Cardiff East and Newport (Ebbw Junction) all trains will travel on the Main Lines.

Handsignalmen

Will be stationed as follows:-

Cardiff West – Down Platform 3 Inner Home Signal. Cardiff East – Down Main Home Gantry Signals. Newtown West – Down Main Home.

Special Train Arrangements

See W.K. Notice.

Phase 'B' 12.15 hrs. Sunday to 06.30 hrs. Monday (or completion)

Absolute occupation of the following lines will be granted:-

Up and Down Main Lines between Long Dyke Junction and Cardiff East. Platforms 1, 2 and 3 at Cardiff General.

Up and Down Middle Lines at Cardiff General.

Platform 4 at Cardiff General (until 15.00).

All lines between St. Fagans and Cardiff West (until 16.30 hrs.).

Method of Signalling

Block conversion arrangements will be applied to those portions of the Up and Down Lines Controlled by Long Dyke Junction to Rumney River Bridge Junction signal boxes inclusive, which under present arrangements are not worked under Absolute conditions.

East of Cardiff all trains will run under final signalling arrangements controlled from the new panel over the Relief Lines initially using Platforms 6 and 7 only; trains must not be crossed to and from their booked routes at Long Dyke Junction.

West of Cardiff until 17.00 hrs. both Up and Down trains will use the Vale of Glamorgan route.

Down trains terminating at Cardiff will be handsignalled out of Platform 4 or 7 to the Carriage Sidings.

The section of line between Cardiff General and Queen Street will be resignalled in time for commencement of normal traffic on Monday.

Will be stationed as follows:-Cardiff West Up Main C.21 Up Relief C.121.
