## NOTICE TO TRAINMEN ETC. SIGNAL AUTERATIONS

# MORRIS COWLEY THURSDAY JANUARY 28TH 1982

Between 08.00 hours and 16.00 hours on Thursday 28 January 1982, or until completion the Divisional Signal and Telecommunications Engineer will be carrying out the following work:-

Morris Cowley Signalbox and all associated Signalling Equipment will be recovered. "No Signalman Key Token" working will be introduced between Kennington Junction and Morris Cowley the token being released from Oxford Panel Signalbox.

At Kennington Junction there will be no alteration to the existing token instruments. At Morris Cowley the token instrument will be housed in the brick Chargemans Office adjacent to the end of the single line. Notice boards marking the commencement and end of the token section and stop boards will be provided as shown on the diagram.

A new three lever Ground Frame will be provided, released by the token, operating the connections as shown on the diagram.

A new single lever Ground Frame will be provided, released by Annetts key, operating the catchpoint situated at approximately  $15\frac{3}{4}$  milepost. The Annetts key will be retained by the "person in charge" at Morris Cowley.

The connection from the single line to the West Siding and the BLMC Sidings on the Up Side will be spiked clipped and padlocked out of use pending recovery. The layout will be altered as shown in heavy type on the diagram.

The Annetts key release associated with Morris Motors Ground Frame will be recovered and the ground frame converted to release by the token.

The Up distant signal will be retained and fitted with a retro-reflective arm. The existing lamp will be recovered.

Occupation of Oxford Panel will be required for the purpose of testing.

All arrangements for the safe working of the line, including the appointment of any Handsignalmen should be made by the Area Manager, Oxford in accordance with Section "E" of the Rule Book.


