NOTICE TO TRAINMEN ETC. - SIGNALLING AND PERMANENT WAY ALTERATIONS

BETWEEN LLANDRINDOD WELLS AND LLANWRTYD WELLS

Staff of the R.S. & T.E. and R.C.E. departments will be engaged in resignalling works from 22.00 hours, Saturday 5.7.86 to 18.00 hours, Sunday 6.7.86.

1. SIGNALLING

The temporary Signalmans cabin at Llandrindod Wells will be closed.

New signalling arrangements will be brought into use as shown in heavy print on the following diagram.

2. PERMANENT WAY

The loop connections at Llanwrtyd Wells Station will be provided with hydro-pneumatic, self-acting points. An elevated electrical point indicator will be provided 50 yards on the approach to each connection. The indicators will display two white lights when the facing points are correctly set.

See Clause 3.2 of the NSTR Instructions in Section 'D' of the Weekly Operating Notice for instructions in respect of working over these points.

3. SYSTEM OF SIGNALLING

The existing Train Staff and Ticket system of signalling will be withdrawn and "No Signalman Token on Single Lines with Remote Crossing Loops" will be introduced, supervised by Pantyffynnon signal box.

The NSTR token instruments will be housed in huts located on the platforms at Llandrindod Wells and Llanwrtyd Wells. The huts are unlocked by a B.R. No. 1 key. Locked boxes, containing green-coloured 'Special Authority Cards' (See Clause 11.3 of the NSTR Instructions in Section 'D' of the Weekly Operating Notice) will be provided in these token instrument huts. The boxes can be unlocked by a B.R. No. 1 key.

The Signalman at Llanwrtyd Wells will remain being responsible for the Train Staff and Ticket working to/from Llandoverly North.

4. GROUND FRAMES

The ground frame at Llandrindod Wells will be unlocked by a token key for the Llandrindod Wells/Llanwrtyd Wells section.

5. TELEPHONES

The telephones shown on the following diagram will communicate directly with Pantyffynnon signal box.

In addition, Members have the opportunity to join signalling related visits to locations on the UK national and London Underground systems; and to other UK Railways.

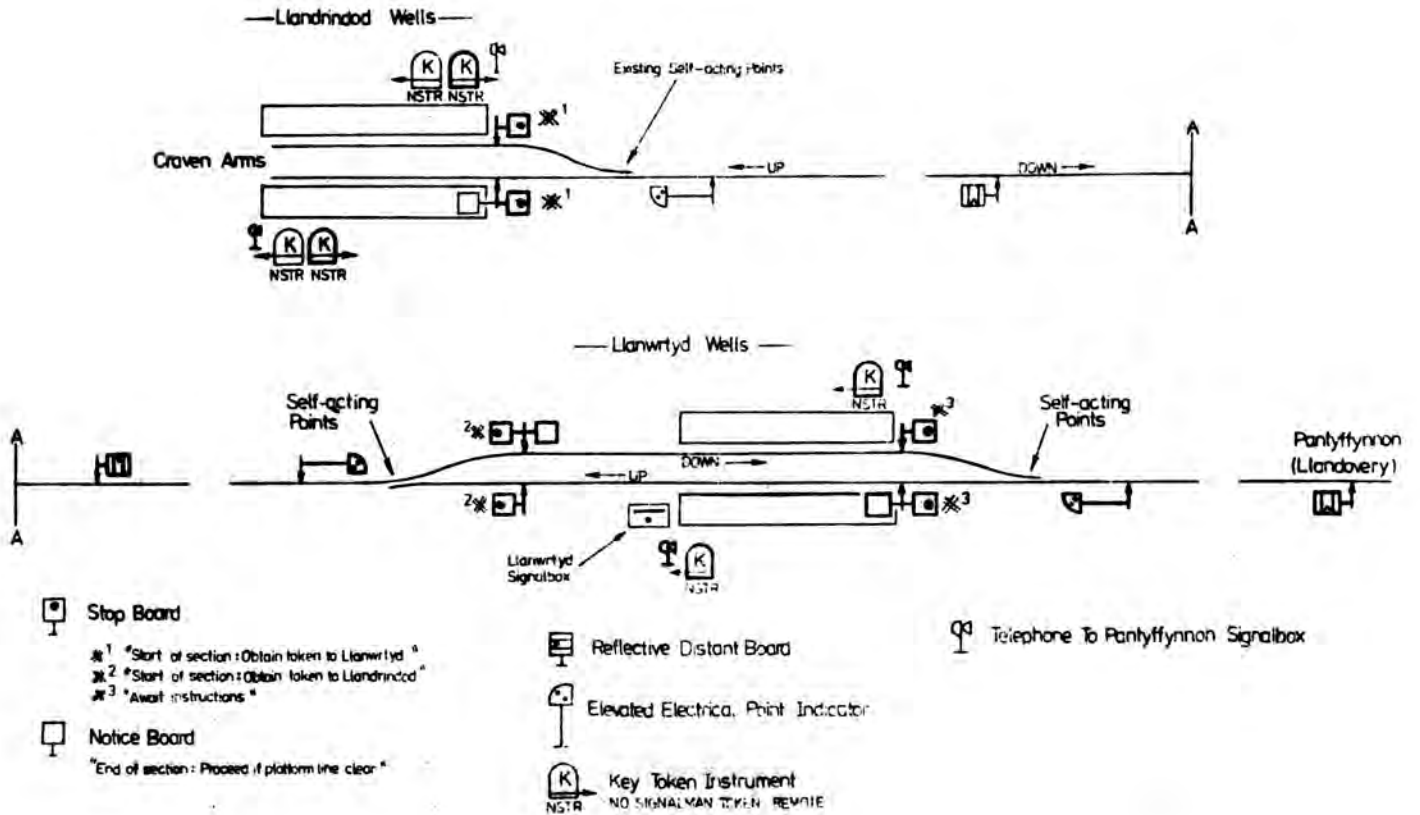
