#### EW UP GOODS LOOP.

The entrance to the new Up Goods Loop will be by a Facing Connection in the Up Relief Line approximately 600 yards on the Didcot side of Moreton Cutting Signal Box, and the exit from the Loop will be the existing trailing connection in the Up Relief Line from the Contractor's Siding about 200 yards on the East side of the Signal Box.

• The new Goods Loop is 2,000 feet long, and the holding capacity will be 90 Ten-ton Wagons, Engine and Van, or 77 Twenty-ton Wagons, Engine and Van.

The Loop is practically level throughout.

A Trailing Connection in the new Loop leading from the Up Sidings, and Independent Discs will also be brought into use.

See Diagram appended,

A telephone to Moreton Cutting Signal Box will be provided near the Trap Points at the entrance to the new Loop to enable guards to inform the signalman when their train with tail lamp complete has drawn inside the Loop points.

During the time the work is being carried out the Up Relief Line Distant Signal will be disconnected and placed at "CAUTION."
